#### COST AND LODGING

The Summer School does not charge tuition.

Applicants admitted will be charged a fee of \$1,500 to cover the costs of lodging, two meals per day, and some additional organized activities in the city of Chicago during the two-week stay in Chicago. Lodging will be at the University of Chicago campus in Hyde Park, Chicago.

The University of Chicago may provide stipends for qualifying applicants to cover the \$1,500 fee as well as the cost of travel to Chicago.

#### APPLYING FOR THE PROGRAM

##### Who Should Apply

The University of Chicago invites Scholars from Mainland China, Hong Kong, and Taiwan to apply to the two-week program. Professors, assistant professors, lecturers, postdoctoral fellows, and advanced graduate students in law are encouraged to apply. Policy makers, scholars, and researchers from other disciplines, including economics, finance, and political science, who are interested in law and legal institutions, are encouraged to apply as well. Applicants should have sufficient command of the English language; all lectures, discussions, and readings will be in English without translation. The Institute for Law and Economics will provide necessary documentation for the visa application process.

Applicants are asked to provide statements outlining background in law and economics, current research interest, and reasons for interest in attending the Summer School. Applicants must provide a CV in both English and Chinese detailing educational background, employment history, and a list of publications.

**Deadline:** Applications must be submitted online by **January 1, 2012**.

**Notification:** Admission notices will be sent to applicants no later than **January 22, 2012**.

申请人应具备足够的英文听说能力。暑期班课程将全程用英文讲授，不提供中文翻译；课堂讨论和阅读材料亦仅使用英文。

#### 申请事项

本暑期班免收学费。

每位学员应缴纳杂费一千五百美元(US\$1500)，用以支付在芝加哥大学校园内两周的住宿、餐费(每日两餐)和暑期班组织的学员活动费用。芝加哥大学法学院将向优秀学员提供奖学金，涵盖杂费和往返芝加哥的旅行费用。

#### THE PROGRAM

The University of Chicago Law School trains international scholars to use the methods of Law and Economics in their own legal systems. The 2012 Chicago Summer School in Law and Economics is intended exclusively for Chinese scholars interested in advanced law and policy study. The theme of the 2012 program is Property Rights and Private Law.

#### 主题

芝加哥大学法学院是“法律经济学”的诞生地和摇篮，至今仍是这门跨学科领域研究和教学的世界中心。在过去五十多年中，芝加哥大学的诺贝尔经济学奖获得者斯蒂格勒、贝克、科斯和划时代的法学家波斯纳法官及爱泼斯坦教授等人彻底改变了法律分析和研究的基石。反垄断法、侵权法、合同法、公司法和财产法等领域的原有分析方法被法律经济学完全颠覆。法律经济学还深刻影响了几乎所有其它部门法。美国的每所法学院和每一本法律教科书都无一例外地涵盖了法律经济学。法律经济学的分析工具也正在全世界范围内获得普遍运用。

#### THE FACULTY



**Eric Posner** has written and edited several books, most recently *Climate Change Justice* (with

David Weisbach), *Contract Law and Theory*, and *The Executive Unbound: After the Madisonian Republic* (with Adrian Vermeule). He has published widely in both private and public law.



**Douglas Baird** is an internationally renowned expert in the fields of commercial law and bankruptcy. He is the author

of dozens of articles in Law and Economics and several books, including widely used casebooks on bankruptcy and contracts and *Game Theory and the Law*. Baird served as dean of the Law School from 1994 to 1999.



**Saul Levmore** writes across many fields of law, including torts, restitution, public choice, and risk regulation.

He holds both a JD and a PhD in economics from Yale. Levmore served as dean of the Law School from 2001 to 2009.



**Omri Ben-Shahar** is an expert in contract and consumer law. He is the author of *More Than You Wanted*

*to Know: The Failure of Mandated Disclosure*. Ben-Shahar holds both a PhD in economics and SJD from Harvard. He is the editor of the *Journal of Legal Studies* and the director of the Institute for Law and Economics at the Law School.
